The directors of VF (the “Directors”) are of the opinion that there is nothing contained in this Notice nor in the proposals detailed herein that conflicts with the guidance issued by and regulations of the Central Bank.**

The Directors have taken all reasonable care to ensure that, as at the date of this Notice, the information contained in this Notice is in accordance with the facts and does not omit anything likely to affect the import of such information. The Directors accept responsibility for the information contained in this Notice.

Unless otherwise indicated, all capitalised terms in this Notice shall have the same meaning as described in the prospectus for VF dated 26 August 2024 and any addenda thereto (the “**Prospectus**”).

## **CHANGES TO THE INVESTMENT MANAGEMENT ARRANGEMENTS FOR VANGUARD FUNDS PLC – NO ACTION REQUIRED**

We are writing to you because you are a Shareholder of one or more sub-funds of Vanguard Funds plc (“VF”). We are making some changes to VF’s investment management arrangements. These changes will not affect the way the sub-fund you invest in is managed. The changes will be effective from **2 January 2025**.

Up until now, Vanguard Group (Ireland) Limited (“VGIL”), the management company of VF, has appointed Vanguard Global Advisers LLC (“VGA”) as the named investment manager for all VF’s sub-funds. For sub-funds that invest in certain regions, VGA currently sub-delegates investment management activities to Vanguard Asset Management Limited<sup>1</sup> (“VAM”), which is a company in the Vanguard group of companies.

Following a review, these arrangements will be simplified. VAM will be directly appointed by VGIL, rather than being sub-delegated by VGA. VGA will no longer be the named investment manager for those sub-funds. VGA will continue to act as investment manager for VF’s other sub-funds. You can see which Vanguard entity will be the investment manager for each sub-fund in the Appendix.

There will be no change to the way any of the sub-funds are managed in practice or to any of the investment objectives, investment policies, risk profiles or annual management charges as a result of the change.

### *Revised Prospectus*

A revised Prospectus reflecting the above changes has been submitted to the Central Bank. Once noted by the Central Bank, the revised Prospectus will be made available on <https://www.ie.vanguard/products>.

### *Is any action required?*

No action is required from Shareholders in respect of the changes outlined in this Notice.
